1. This application form is used for one of the following types of application only:

2. For HKID Card holder, the applicant must fill in HKID Card number even if he also holds other types of travel documents.
3. The applicant should provide all competent person and training course information that is relevant to this application and submit the photocopies of the documentary proofs.
4. The applicant should produce the original identity document and original documentary proofs for checking at the counter. The originals will be immediately returned to the applicant after checking.
5. The new/renewal application for approval as a competent person will be valid for 3 years.

**APPLICATION INSTRUCTIONS**

Application for approval or renewal of approval as a competent person shall be made to OFCA. The application is free of charge. The applicant may submit application following the procedures below:

- (a) Complete the application form according to the requirements stipulated therein

1. 要獲得認可為合資格人士，申請人應符合以下的要求：
  - (a) 申請人為機電工程署根據《供電電纜（保護）規例》（第 406H 章）已被認可為確定地下電纜所在的合資格人士，並持有由機電工程署發出，而有效期最少為 6 個月的相關認可證明書；及
  - (b) 申請人曾修讀獲通訊辦認可的關於探測地下電訊線路的課程並取得合格成績。請瀏覽通訊辦網頁“[www.ofca.gov.hk](http://www.ofca.gov.hk)”參閱獲認可的課程清單。

## 續期申請

1. 合資格人士的認可續期申請，須於現有認可的有效期屆滿前 1 個月至 4 個月的期間內提出。

如獲認可的合資格人士的姓名或地址有任何更改，該人須於作出更改後的 21 日內將更改的詳情以書面通知通訊辦。

## **QUALIFICATION REQUIREMENTS FOR APPROVAL AS A COMPETENT PERSON**

1. To be qualified for approval as a competent person, the applicant should meet the following requirements:
  - (a) the applicant is a competent person approved by the Electrical and Mechanical Services Department (“EMSD”) under the Electricity Supply Lines (Protection) Regulation (Cap. 406H) (“ESLPR”) for locating the underground electricity cables and holds a relevant certificate of approval issued by EMSD with a remaining validity period of at least six months; and
  - (b) the applicant has attended and passed a training course recognized by OFCA in relation to the detection of underground telecommunications line. Please visit OFCA’s website “[www.ofca.gov.hk](http://www.ofca.gov.hk)” for the list of recognized training courses.

## **RENEWAL OF APPROVAL**

1. Application for renewal of approval as a competent person shall be made at least 1 month before, but not earlier than 4 months before, the expiry of the current approval.

## **NOTICE OF CHANGE OF PARTICULARS**

Where there is any change in the particulars of the name or address of a person who is approved as a competent person, the person shall give written notice to OFCA of the changed particulars within 21 days after the change takes place.
